When President Biden signed the Bipartisan Infrastructure Law (BIL), or the Infrastructure, Investment & Jobs Act (IIJA), in November of 2021, he put into action the largest infrastructure investment in American history—\$1.2 trillion over five years. Less than one year later, President Biden signed the Inflation Reduction Act (IRA), another massive federal investment focused on accelerating the clean energy transition through grants and tax credits. As Governor of Louisiana, I recognized the tremendous opportunity that the BIL and IRA represent for our state. I continue to believe that these investments in infrastructure will transform Louisiana by providing much needed repairs to our roads and bridges, delivering broadband internet to every household, ensuring resilient coastal infrastructure, updating water systems, addressing legacy pollution, and advancing the clean energy transition.

Given the opportunity presented by the BIL and IRA, I tasked my staff and all of our relevant state agencies to coordinate and collaborate with each other and with our local and tribal governments, industry partners, and community organizations to maximize Louisiana's share of these national investments. I prioritized pursuit of funds that would advance our Climate Action Plan, like funds that support the development of clean, renewable energy and that tackle methane emissions from orphaned wells. I took steps to provide local governments with state-funded technical assistance and matching funds support. I also stressed the importance of ensuring that the opportunities from the BIL and IRA benefit all Louisianans. That meant identifying projects that would benefit disadvantaged communities and leveraging those projects to support Louisiana businesses and to create good jobs for our residents.

I am proud of what Louisiana's state agencies, tribal governments, and local communities accomplished in the first two years of BIL and the first year of IRA implementation. As you read this 2023 Annual Report, you will see details on the more than \$10 billion Louisiana has secured to date, how state agencies coordinated and collaborated, and how my office engaged with the public. These federal funds are a once in a generation investment, and I encourage the next administration to continue to do all it can to maximize benefits to the people of Louisiana.

Introduction

Commencing with the signing of the Infrastructure Investment and Jobs Act (IIJA), also known as the Bipartisan Infrastructure Law (BIL), on November 15, 2021, and followed by the enactment of the Inflation Reduction Act (IRA) on August 16, 2022, the nation began down a path toward extraordinary infrastructure progress. These landmark pieces of federal legislation symbolize a generational investment, empowering state, tribal, and local governments and communities to address long-overdue infrastructure improvements, ensure universal access to broadband internet, accelerate the clean energy transition, make needed upgrades to water systems, and generate employment opportunities for their residents.

Investments from the BIL include:

Roads and Bridges: The BIL reauthorized federal surface transportation programs and allocated \$110 billion in new funds for roads, bridges, and major projects.

Electric Vehicle (EV) Charging: The BIL invested \$7.5 billion to establish a nationwide network of EV chargers, with a particular focus on rural, disadvantaged, and hard-to-reach communities. Additionally, \$5 billion was allocated for low/zero emission buses and \$2.5 billion for low/zero emission ferries.

Multimodal (Planes, Trains): The BIL earmarked \$66 billion for the nation's railways to improve safety, expand rail service, eliminate the Amtrak maintenance backlog, and modernize the Northeast Corridor. The law also invested \$25 billion in airports to reduce congestion and emissions near these facilities and to drive electrification and other low-carbon technologies.

Energy: The BIL invested \$65 billion in clean energy transmission, providing funding to states for upgrading transmission lines, establishing the new Grid Deployment Authority, and promoting smart grid technologies. Additionally, the BIL invested in research and development for advanced transmission and electricity distribution

technologies, as well as next-generation energy technologies. The BIL also included substantial investments in energy efficiency for families, communities, and businesses, encompassing home energy upgrades and weatherization funding.

Broadband: The BIL invested \$65 billion in broadband infrastructure across the United States, including funding for rural broadband, middle-mile connectivity, and low-income households. Funding was also provided for state digital equity plans and workforce opportunities related to broadband.

Water and Environmental Remediation: The BIL invested \$54 billion in clean drinking water, with dedicated funding for water infrastructure in tribal communities and lead service line replacement. The BIL also provided \$21 billion to address legacy pollution, including funds to clean up Superfund and brownfield sites, reclaim abandoned mine lands, and plug orphaned oil & gas wells.

Resilience: The BIL included \$46 billion to combat the effects of climate change and protect against flood, drought, wildfire, and ecosystem deterioration. The BIL also authorized \$1 billion for a state and local cybersecurity grant program to promote resilience against cyberattacks.

Expanding upon these investments, the IRA authorized a substantial \$370 billion¹ to address the pressing challenges of climate change and facilitate the transition to clean energy. This significant investment aims to foster American innovation with the goal of reducing energy costs, spurring private investment in clean energy solutions, fortifying supply chains, and generating well-paying jobs. The IRA's tax credit provisions could result in significantly more investment in the clean energy transition over the next ten years should uptake of IRA tax credits exceed current government estimates.

The 2023 Louisiana BIL and IRA Annual Report builds on the 2022 Louisiana BIL Annual report, which outlined Governor John Bel Edwards' priorities for

BIL implementation in Louisiana. The 2023 Annual Report details the progress made in two years of implementation of the BIL and one year into implementation of the IRA.

Priorities

In response to these historic federal investments, Governor Edwards established five key priorities to serve as guiding principles for Louisiana's implementation and pursuit of federal funding. Collectively these priorities aimed to ensure lasting benefits for generations of Louisianans.

1) Maximize Funding through Coordination and Collaboration

In addition to the formula funding allocated directly to states, the laws offer the chance to pursue discretionary programs. These competitive programs constitute approximately 40% of BIL funding and the majority of IRA investments that are not tax credits. These substantial discretionary funding opportunities are accessible to states, tribes, local municipalities, nonprofit organizations, industry stakeholders and other entities, as well as various partnership arrangements, underscoring the importance of prioritizing coordination and collaboration to optimize the funds received by Louisiana.

2) Advance the State's Climate Action Plan

In January 2022, Governor Edwards approved the state's inaugural Climate Action Plan (CAP). Governor Edwards made it a priority to align federal infrastructure grant funding with the goals and recommendations of the Climate Action Plan to accelerate progress. The opportunity to reduce greenhouse gas emissions and limit the severity of climate change will strengthen Louisiana's ability to maintain economic competitiveness in a low-carbon future.

3) Support Local Governments

Local governments, municipal planning organizations, regional partnerships and other eligible entities were actively encouraged to submit applications

for various BIL and IRA discretionary programs. Recognizing that some local governments, despite their significant needs, faced challenges in terms of capacity and funding when pursuing federal grant opportunities, Governor Edwards worked with the Louisiana legislature to set aside \$25 million in 2022 to assist local governments in preparing applications and to provide financial support to meet federal match requirements. These funds bolstered the efforts of the Louisiana Infrastructure Technical Assistance Corporation (LITACorp), a collaborative initiative between the Louisiana Municipal Association and the Louisiana Police Jury Association.

4) Generate Good Jobs

The workforce opportunities from the BIL and IRA span diverse sectors and industries such as construction, electrification and weatherization. Governor Edwards emphasized that this substantial workforce demand is poised to create quality jobs for the people of Louisiana. Moreover, many BIL and IRA programs include workforce training and development as eligible expenditures. For example, the state's proposal for the Broadband Equity and Access Deployment program (BEAD) includes a workforce training component, and the state's proposal for the Grid Resilience Innovation Program (GRIP) is expected to create 875 new graduates of workforce training, pre-apprentice, and apprenticeship programs by 2030.²

5) Distribute Funding Equitably

Governor Edwards recognized that the BIL and IRA present a once-in-a-generation opportunity for Louisiana communities and workers and that it was essential that funding be distributed equitably over several key metrics: realized benefits, contracting opportunities, and jobs. Many BIL and IRA-funded programs are covered under the federal Justice40 Initiative, which sets a goal that 40% of benefits from these federal investments will flow to historically marginalized or disadvantaged communities.

In alignment with Justice40 and with an understanding that 56% of Louisiana's communities are considered disadvantaged for the purposes of Justice40,³ Governor Edwards issued Executive Order Number JBE 2022-19, Equitably Coordinating Louisiana's Statewide Infrastructure Investments, asking each relevant state agency to develop action plans to:

- (1) increase access to the contract selection process for small, minority, women, veteran-owned and disadvantaged business enterprises for all federal BIL-funded contracts.
- (2) engage with local and tribal governments, nonprofits and other community organizations to increase access to BIL funding opportunities.
- (3) require contractors to submit utilization plans to agencies that include the contractors' methods of acquiring and utilizing small, minority, women, veteran-owned and disadvantaged business enterprises in the performance and completion of BIL-funded contracts.
- (4) require that contractors submit utilization reports every 30 days.
- (5) require that contractors demonstrate their methods of hiring and employing as many local residents and businesses as is consistent with providing efficient and effective services under BIL-funded contracts.

As of December 2023, Louisiana secured over \$3.41 billion from 170 Justice40 covered projects, representing a consequential investment that should have a profound impact on Louisianans living in disadvantaged areas. This investment covers a range of categories, from road safety, internet access, environmental cleanup, public transportation and more.

Leadership

State Cabinet Engagement

Since the passing of the BIL, Governor Edwards annually convened relevant cabinet secretaries and key agency leaders to explore the scale of opportunities available at two Resilient Infrastructure Workshops. Over the course of the workshops, leaders discussed infrastructure priorities and needs as well as opportunities for coordination and collaboration. In addition, relevant cabinet members briefed the Governor in regular monthly cabinet meetings and at specially designated infrastructure cabinet meetings with updates on BIL and IRA grant funding and progress to date.

Office of Governor John Bel Edwards

Statewide Infrastructure Implementation Coordinator

In January 2022, White House Infrastructure Coordinator Mitch Landrieu sent a letter to all Governors asking them to appoint a state level Infrastructure Implementation Coordinator. In response, Governor Edwards designated Jackson Wright, Director of Special Projects, to serve as Infrastructure Implementation Coordinator to ensure the successful implementation of the BIL (and later the IRA) and maximize the opportunities for Louisiana. In this role, Wright served as a liaison between the Louisiana Governor's Office and the White House Infrastructure Implementation Team, as well as the point of contact for local, tribal and non-governmental stakeholders. He also worked closely with LaKesha Hart, State Planning Manager with the Office of Planning and Budget within the Division of Administration, to coordinate BIL efforts through various state agencies. They maintained regular and ongoing communication with state Agency Infrastructure Coordinators (AICs) and convened monthly meetings with all AICs. Wright also oversaw the Grants Hub, which supported the state's coordination efforts and made support available to state agencies with their BIL and IRA grant applications and administration.

Agency Infrastructure Coordinators

The Commissioner of Administration and the Infrastructure Implementation Coordinator asked each relevant state agency to designate an Agency Infrastructure Coordinator for the purposes of coordination and collaboration. The state agencies with Agency Infrastructure Coordinators for 2022-2023 were:

- Department of Transportation and Development
- Department of Natural Resources
- Department of Environmental Quality
- Coastal Protection & Restoration Authority
- Department of Public Safety
- Department of Wildlife and Fisheries
- Division of Administration, Office of Community Development
- Division of Administration, Office of Technology Services

- Louisiana Housing Corporation⁴
- Department of Agriculture and Forestry⁴

The AICs met with the State Infrastructure Coordinator and State Planning Manager monthly to give updates on applications and program progress, along with facilitating interagency collaboration.

Approach

In addressing the state's infrastructure priorities, the Governor's Office adopted a holistic approach, delivering with a focus on collaboration, engagement and supporting Louisianans from all corners of the state.

Emphasizing Partnership & Cooperation

To facilitate continuous collaboration between government and non-governmental entities, the IIC implemented various mechanisms to encourage open discussions and issue resolution. These mechanisms included:

- (1) Monthly meetings held among the State Infrastructure Coordinator, State Planning Manager, and AICs to review opportunity pipelines and areas for cross-agency collaboration, support applications from other entities, deliberate on significant infrastructure developments, frame cabinet briefings, initiate interagency partnerships, and solicit agency input on public-facing elements such as project maps and the infrastructure website.
- (2) Subject matter working groups to address specific issues pertinent to multiple entities. Recent topics include the electric grid, broadband permitting, and other key matters.
- (3) Targeted stakeholder forums to facilitate direct interaction and exchange of insights between the state government, other government entities, and the private sector.
- (4) Workshops and trainings to provide opportunities for agency leadership and staff to build capacity and develop strategic plans for pursuing and implementing BIL and IRA funded programs. For example, the US Climate Alliance and Emerald Cities Collaborative supported the Governor's Office in hosting a series of workshops and trainings for state agencies on implementing the requirements of the lustice40 initiative.

These initiatives collectively contributed to fostering an environment of collaboration and informed decision-making among diverse government and non-governmental entities.

Concentrating on Public Engagement

The Governor's Office undertook a comprehensive approach to ensure that Louisianans were well-informed about infrastructure progress through various initiatives.

- (1) Monthly webinars: Organized around programs of public interest, these webinars informed the public about important implementation updates, available opportunities, program requirements and timelines while providing an open forum for public questions and interaction with state leadership.
- (2) Weekly Newsletter: Distributed to nearly one thousand recipients to offer updates on the release of funding opportunities, award announcements, and other pertinent information
- (3) Infrastructure Website: infrastructure.la.gov features an interactive map displaying ongoing projects, news, events, open opportunities, stakeholder engagement details, infrastructure priorities, and links to state and federal resources.
- (4) Participating in Events: State representatives attended infrastructure related conferences and local summits, fostering connections with nonprofits and local stakeholders and promoting in-person discussions. For example, Louisiana Economic Development's 2023 Small Business Summit included two panel discussions on how small businesses could benefit from the opportunities flowing from the BIL and IRA. State agency procurement staff with knowledge of BIL and IRA opportunities were also present for the reverse tradeshow.

Supporting Local Governments

With support from the Governor's Office, LITACorp has provided crucial support to Louisiana's local governments, particularly small, rural, and disadvantaged communities. LITACorp has actively engaged in

understanding the unique needs of small, rural, and disadvantaged communities, offering valuable technical assistance to help municipalities navigate grant applications and administration, facilitating partnerships to enhance grant competitiveness, and implementing a program to provide non-federal match assistance thereby easing the financial burden associated with federal cost-share requirements.

In a further commitment to supporting local governments, the Governor's Office of Rural Development secured a \$2 million award from United States Department of Transportation (USDOT)'s Regional Infrastructure Accelerator (RIA) program for the Acadiana region. Additionally, the Office of State Planning applied to the US Department of Transportation's Thriving Communities Program for the Regional Pilot Program. If awarded, the Office of State Planning will provide technical assistance, planning, and capacity-building support to a set of six pilot communities.

Advancing the Climate Action Plan

The Governor's Office took steps to advance the state's Climate Action Plan (CAP) by leveraging federal funding and developing comprehensive strategies. Since the passage of the BIL and IRA, Louisiana has seen more than \$1.4 billion in federal investments in clean energy and the power grid, direct air capture, electric vehicles and charging infrastructure, plugging of orphaned wells, and more. The state received \$5 million in Climate Pollution Reduction Program Planning Grants, of which \$3 million was awarded to the Division of Administration to develop plans that align with and expand upon the state's CAP, setting the stage for interested parties in Louisiana to apply for Climate Pollution Reduction Program Implementation Grants.

Additionally, Louisiana is awaiting the outcome of the Environmental Protection Agency's (EPA) Solar for All Competition, where the Department of Natural Resources (DNR) submitted an application seeking the maximum award of \$250 million.


Funding

As of December 2023, over \$10.2 billion in funding from the Bipartisan Infrastructure Law and the Inflation Reduction Act has been announced for Louisiana. These resources support over 780 awards and projects, with 68% of awards and projects located in disadvantaged areas.⁶

This section provides a summary of BIL and IRA funding by infrastructure category with selected highlights described for each category. Highlights are designed to provide relevant examples and are not a comprehensive accounting of awards. For a full accounting of awards, see Appendix A which catalogs specific funding amounts by program within categories.

Roads, Bridges, and Safety

\$3.82 billion in funding from numerous BIL programs has been announced to improve the state of its roads and bridges and enhance road safety. The Safe Streets and Roads for All program is empowering several Louisiana local

entities, including the Acadiana Planning Commission and the City of Natchitoches, to develop action plans to improve streets in both rural and urban communities with over \$5 million in awarded funds. Louisiana applicants have also been successful in the pursuit of over \$27 million from the Natural Gas Distribution Infrastructure Safety and Modernization Grant Program. Other major wins include awards from the Department of Transportation's multimodal programs, approximately \$109 million in Local and Regional Project Assistance (RAISE) Grants, \$59 million to the City of Baton Rouge for the Nationally Significant Freight and Highway Projects (INFRA) program, and \$150 million from the National Infrastructure Project Assistance (MEGA) grant for the Calcasieu Bridge project.

Clean Energy & Power

More than \$1.64 billion in federal funding has been announced to support the transition to clean energy. Louisiana has secured significant investments to further the clean energy transition, including \$603 million for a Direct Air Capture Hub in Calcasieu Parish, expected to generate over 2,300 jobs in Southwest Louisiana. Additionally, over \$320 million in discretionary funds were awarded from the Battery Materials Processing Grant Program. Furthermore, Louisiana was allocated more than \$212 million in IRA-funded Home Energy Rebates, facilitating residential energy efficiency. The Louisiana Department of Natural Resources was successful in the pursuit of \$250M in Grid Resilience and Innovation funding for the Hubs for Energy Resilient Operations (HERO) program, which will fund the creation of local resilience hubs. DNR has also begun the process to distribute over \$15 million in formula funds from the 40101(d) Grid Resilience program. The Louisiana Housing Corporation will leverage over \$30 million from the Weatherization Assistance Program to help reduce energy bills and improve the health and safety of low-income homes across the state.

Resilience

\$1.3 billion has been announced for community resilience and resilient infrastructure, including the largest award in the nation from the

Safeguarding Tomorrow Revolving Loan Fund (STORM) program and over \$50 million awarded from the Building Resilient Infrastructure and Communities (BRIC) program. Louisiana has also received \$882 million in federal investment from the US Army Corps of Engineers across more than two dozen projects. The Department of Transportation and Development will receive over \$79 million through the Promoting Resilient Operations for Transformative, Efficient, and Cost-Saving Transportation (PROTECT) program over three years. Four Louisiana applicants received over \$24 million from the Urban & Community Forestry program.

Environmental Remediation

Over \$174 million has been announced for programs related to addressing legacy pollution. \$41 million has been announced for National Oceanic and Atmospheric Administration (NOAA) programs to address marine debris and restore coastal habitats. The state has also been successful in implementing the Department of Interior's program to plug Orphaned Oil and Gas Wells, with over 600 wells already plugged. Important to Louisiana communities seeking assistance in pursuing funding, the EPA awarded \$13 million to the Deep South Center for Environmental Justice as part of its Environmental Justice Thriving Communities Technical Assistance Centers Program.

Airports, Ports & Rail

\$355 million has been announced for airports, ports, and rail projects. New Orleans to Mobile passenger rail received over \$178 million from the Consolidated Rail Infrastructure and Safety Improvements (CRISI) program. The Federal Railroad Administration announced three \$500,000 awards from the Corridor Identification and Development Program to initiate passenger rail service for three lines impacting Louisiana: Baton Rouge to New Orleans, New Orleans to Mobile, and the I-20 Corridor from Texas to Mississippi. Louisiana also received over \$89 million in awards to airports across the state and the Morgan City Harbor and Terminal District received \$10 million from the Port Infrastructure Development Program (PIDP).

Water

Over \$265 million in grant funding has been announced, empowering Louisiana's local water systems to make critical improvements, address emerging contaminants, and remove lead service lines through the Clean Water State Revolving Fund (CWSRF) and the Drinking Water State Revolving Fund (DWSRF).

Broadband

Over \$1.58 billion has been announced for broadband and internet-related grants. Louisiana was the first state in the nation to receive approval for the Broadband, Equity, Access, and Deployment (BEAD) program, and can begin implementation of the \$1.3 billion program to provide universal broadband access. Additionally, 530,000 Louisiana households have signed up for the Affordable Connectivity Program, ensuring that all communities can afford to adopt broadband when available.⁷

Public Transit

Over \$225 million has been announced for public transportation, with funds for ferries, buses, and more. The Plaquemines Parish Ferry Department was awarded \$2.8 million from the Ferry Boats and Ferry Terminal Facilities program. The Department of Transportation and Development received \$25 million from the Rural Surface Transportation Grant Program to fund ferries in Plaquemines and Cameron parishes.

Electric Vehicles (Charging, Buses, Ferries)

Over \$164 million has been announced for electric vehicles, including funds for charging infrastructure and electric buses. Seven Louisiana school districts received \$35 million from the Clean School Bus Rebate Program for the purchase of 87 electric buses. The New Orleans Regional Transit Authority received over \$70 million from the Low- and No-Emission Bus program for new electric buses and associated charging infrastructure.

Louisiana's National Electric Vehicle Infrastructure program plan was approved by the Federal Highway Administration (FHWA) and the program will administer an estimated \$73 million over a five year period.

Conclusion

Implementation of the BIL and IRA in Louisiana under Governor John Bel Edwards has resulted in more than \$10 billion in announced funds, Louisiana being the first state to receive approval for its \$1.3 billion broadband program, and the execution of a statewide vision and collaborative processes by Cabinet Secretaries and the State Infrastructure Implementation Coordinator. Over the next several years, more funds will be announced for Louisiana, entities throughout the state will be able to apply for IRA tax credits, and Louisiana's infrastructure will be transformed. As Governor Edwards noted in his opening letter, these federal funds remain a once in a generation investment and can continue to provide meaningful benefits to the people of Louisiana under the next gubernatorial administration.
